Online Summer Camp Parent/Guardian Permission Slip

<u>Assumption of Risk:</u> I am aware of the risks associated with my child's participation in the above event remotely and do hereby voluntarily assume full responsibility for supervision of my child and any risk of loss, property damage or personal injury, including death, that may result from participation in event activities.
